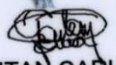

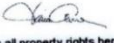

INSTALLATION PROCEDURE VULKEN 350NF

To whom it May concern,

The application instructions for waterproof under tile systems have been followed, according to TREMCO recommendations, In accordance NOA # 20-0629.08 as follows.

- 1- Preparation of the Balcony (picture #1)
 - The materials to be used must be presented, and these must be purchased from a distributor authorized by TREMCO, so that your application can be approved and guaranteed.
- 2- Blow the Balcony (picture #2)
 - The concrete surface shall be properly cleaned so that the surface to receive the coating, sealant or liquid-applied, must be free of mold, paint and dust.
- 3- Total sealing of the balcony with Dymonic 100 (picture #3)
 - Sealing of the joint, perimeters and railings. Allow sealant to cure overnight.
- 4- Application of the Vulkem Primer #171 (picture #4)
 - Allow 30 to 45 minutes for primer to become tacky before applying sealant, coating, or membrane.
- 5- Application of the Vulkem 350NF (picture #5 and #6)
 - Prior to use, Vulkem 350NF should be mixed for a minimum of 5 min. Apply 40-60 mils thick. Allow a minimum of 4 to 6 hours and a maximum of 24 hours to cure.
- 6- Application of the Epoxy Primer (picture #7 and #8)
 - Mix part A and part B, Apply a topcoat of Tremco Epoxy Primer at a minimum thickness of 10-12 wet mils.
- 7- Broadcast to refusal (flood coat) the material with 30 to 40 mesh (picture #9)
 - Immediately following the application of the Tremco Epoxy Primer broadcast to refusal (flood coat) the material with 30 to 40 mesh diameter silica sand. Allow this to fully cure overnight. Vacuum or blow off any excess sand.
- 8- Final inspection
 - Pass final inspection.
